



Movement/Dance/Fitness Waiver and Release

REGISTRATION CONSENT:

By registering for this class, you are consenting to this waiver in lieu of an original signature on paper. You have the right to request that you sign a paper copy instead which we can have ready for you for your next studio visit. After your consent, you may request a digital or paper copy of this waiver for your records. Your agreement to use registration as consent with us will continue for the full duration of the class or workshop. Withdrawal of this consent must be done in writing and requires withdrawal from the class.

Registration in any movement, dance, or fitness class or workshop run by The Umbrella Arts Center with any of our Independent Contractors or employees as teachers, confirms that you have read and understand the following:

I understand that physical exercise of any kind can be strenuous and subject to the risk of serious injury. You are urged to obtain a physical examination from a doctor before participating in any class or workshop where your participation requires physical activity.

I recognize that such physical activity and exertion may be difficult and strenuous and may cause or aggravate a physical injury or medical condition.

I agree that I engage in any physical exercise or activity, entirely at my own risk.

Liability Waiver:

You acknowledge that you have carefully read this "waiver and release" and fully understand that it is a release of liability, without limitation, all injuries which may occur because of:

- (a) Your participation in any class/workshop session or activity or training therein and
- (b) Instruction, training, supervision by your instructor of The Umbrella Arts Center.

In connection with my involvement in glass art classes at The Umbrella Arts Center, I hereby release The Umbrella Arts (Emerson Umbrella Inc.) it's agents, representatives, successors, and The Umbrella management and employees, from all liabilities, actions,

claims, damages, demands, costs, and expenses which I am now or in the future have against them arising out of or in any way connected with my participation in a class for which I voluntarily chose to participate. I understand that this waiver includes, but is not limited to, all injuries or illness to me and loss of personal property.

To the extent that statute or case law does not prohibit release for negligence, this release is also for negligence on the part of The Umbrella. If any portion of this release from liability shall be deemed by a Court of competent jurisdiction to be invalid, then the remainder of this release from liability shall remain in full force and effect and the offending provision or provisions severed here from.

I understand and accept the inherent risks involved in dance, movement, and fitness activities; I do so voluntarily with the knowledge of the danger of the inherent risks and assume full responsibility for my own safety.

I acknowledge that I understand this content and that this release cannot be modified by me but can be changed by The Umbrella prior to the start date of any specific class to which it applies.
